2017 BPTR Mid-Range Matches - 200yd, 300yd & 600yd

Dates:

- 30-shot matches – Saturday, Mar 25, Saturday, May 6, Saturday, Sept 9 & Saturday, Oct 14.
- Course-of-fire for 30-shot matches is 4-sighers & 10-shots for record in 30 minutes at each distance, position or prone.
- 60-shot Eastern Regional & NJ State Championship – June 10/11. Course-of-fire is 4-sighters & 10-shots for record in 30 minutes at each distance, TWICE, position or prone.

Competitors: All matches are NRA 'registered' meaning that national records may be set. NRA membership is NOT required to compete in or win the match. However, NRA membership is required to set national records and ANJRPC membership & NJ residency is required to be the NJ State Champion.

Entry Fees: \$20 for a 30-shot match and \$35 for the 60-shot match (60-shot match includes lunch & drawing for prizes).

Awards & Prizes: 30-shot match winners will be awarded a nominal cash prize. 60-shot match winners will be awarded a medallion and the first two places in prone & position will be award a nominal cash prize. In addition, all competitors who complete and turn-in their completed equipment list will be entered in the drawing for various prizes that have been generously provided by our many BPCR suppliers (see list below).

Entry: Advance entries are helpful in squading. Entries must be received by 8:30 A.M. the day of the match. Send advance entries (your full name, address, e-mail & NRA & ANJRPC membership #s if you have) to: Glenn Davis, 1035 McGeary Place, Mays Landing, NJ 08330, gpadavis2@comcast.net

Firing Starts: Squading tickets will be available at the Range Office at the 600yd line at 8:00 A.M. and must be picked up by 8:30 A.M. There is a mandatory competitors briefing/safety meeting at 8:45. The first relay (Match #1, 200yd) will commence firing at 9:00 A.M.

Target Pullers: All competitors must score on the line and pull targets in the pits on their off-relays. There are a number of paid (by the competitor, \$30 for a 30-shot match and \$40 for the 60-shot match) target pullers available. Any competitor who wishes to hire the services of a paid target puller must contact the match director a minimum of 10-days prior to the match to make arrangements for same. The competitor is responsible for paying the target puller. If you request a target puller and do not attend the match you are still responsible for paying the target puller if no one else uses that puller at the match.

Rules: All competitors must wear eye & ear protection on the firing line when firing, scoring and in the pits. Muzzle loaders are welcome and will be squadded together, if possible. All current NRA Black Powder Target Rifle Rules apply:
