Rules: Current NRA rules will govern the conduct of the match.

Competition: Open to all.

Rifles Allowed: Any Rifle/ Metallic Sights - Rule 3.2; NRA Match Rifle - Rule 3.3; Palma Rifle - Rule 3.3.1; NRA Any Sight Match Rifle/Tactical Rifle - Rule 3.3.2 (See Note); F-Class - Rule 3.4 (a), (b)

No compensators or muzzle brakes allowed – Rule 3.16.

Targets: MR-1 and MR-1FC

Classification: The NRA High Power Classification cards or temporary score books will be used.

Categories: Match Rifle, Palma, F-Open and F-TR.
A minimum of 5 shooters is required to form a class/category.
Classes and/or categories will be combined if less than 5 shooters per class/category.

Squadding: At Statistical Office commencing at 0700. Prepaid entries will be squadded first with preference given to those competitors shooting both days. Entries made by telephone cannot be guaranteed. Entries end at 0830 the day of the match and restricted to first 48 paid competitors.

Firing commences at 0900.

Awards: Awards will be given in each category and class for each match on each day.
Awards will be given in multiples of 5.
Competitors may not win more than one award in each match.
Classes and/or categories may be combined at the discretion of the match director.

Note: Scoped rifles utilizing the MR-1 target (600 yard) will compete only with other scoped rifles combined into a separate category (Rule 3.3.2 a). No classification system will be used. A minimum of 5 competitors using scoped rifles on the MR-1 target is required for awards.

Entry Fees: \$50.00 each day. Two-day entry fee \$90.00.

Challenges: \$2.00 per challenge LOST.

Saturday

- Match #1** 600 yard slow fire. Unlimited sighters, 20 rounds for record. Time limit of 30 minutes
- Match #2** 600 yard slow fire. 2 sighters, 20 rounds for record. Time limit of 22 minutes
- Match #3** 600 yard slow fire. 2 sighters, 20 rounds for record. Time limit of 22 minutes
- Match #4** Aggregate of Matches 1, 2, and 3.

Sunday

- Match #5** 600 yard slow fire. Unlimited sighters, 20 rounds for record. Time limit of 30 minutes
- Match #6** 600 yard slow fire. 2 sighters, 20 rounds for record. Time limit of 22 minutes
- Match #7** 600 yard slow fire. 2 sighters, 20 rounds for record. Time limit of 22 minutes
- Match #8** Aggregate of Matches 5, 6, and 7.
- Match #9** Aggregate of Matches 4 and 8.
