Course of fire: Match 1 RimFire 900

Match 2 CenterFire 900 any center up to .45 caliber

Targets: NRA B6 NRA B6C NRA B8C

<u>Classification:</u> Standard NRA Classification will be used. Unclassified competitors will be

entered in the Master Class.

<u>Scoring targets:</u> Targets will be scored by the shooters. After verification the scores will be sent

to the NRA. Challenge fee \$2.00 each challenge. See NRA rule 16 for procedure.

merged class of more than 5 exists.

water. There will be a short 15 minute break between matches.

<u>Use of alcohol before or during match is forbidden and will result in offenders expulsion and forfeiture of all fees.</u>

<u>Directions to Range</u>: <u>Traveling on Rt. 55</u>, exit #24-Rt. 49 E. to Tuckahoe, continue 2.6 miles. Range entrance will be on left.

Traveling north or south on Rt. 50, turn west on Rt. 49, continue approx. 13.8 miles. Range entrance will be on right.

<u>Traveling south on Rt. 54</u> to junction of Rt. 40, turn left go to far right lane, turn right on to Tuckahoe Rd. Continue to right fork-Union Road—continue to dead end on Rt. 49. Turn right 4/10 mile, range entrance will be on right.

<u>Traveling on Garden State Parkway</u> exit 38A Atlantic City Expressway to Camden/Philadelphia. Continue on Expressway exit at Hamilton Mall/Rt 40W. Continue on Rt. 40 W through Mays Landing. You will pass a diner and a WaWa on the right (traffic light at WaWa). Continue to next traffic light turn left and then right onto Bear's Head Rd./Mays Landing Rd./Millville Rd. Continue several miles, crossing railroad tracks continue again several miles to Union Rd. Turn left to dead end at Rt. 49. Turn right 4/10 mile, range entrance will be on right.
