Rules: All current NRA High Power Rules apply.

Competition: Open to all.

Rifles Allowed: Service Rifle - Rule 3.1; Any Rifle – Rule 3.2; NRA Match Rifle – Rule 3.3; Palma Rifle - Rule 3.3.1; F-Class Rifle - Rule 3.4 (a), (b) ; Midrange (prone) Tactical Rifle (AR) – Rule 3.3.3; F-class rifle to include new F-class designation as of 2026 Rules changes as applicable

No compensators or muzzle brakes allowed – Rule 3.16.1

Targets: MR-1 and MR-1FC

Classification: The NRA High Power Classification cards or temporary score books will be used

Categories: A minimum of 5 shooters is required to form a class/category.

Squadding: At Statistical Office commencing at 0730 and ending at 0830 the day of the match
Online preregistration is strongly recommended

Range limit 48

Awards: Classes and/or categories will be combined at the discretion of the match director.
Awards will be given in each multiple of 5.
Competitors may not win more than one award in each match.

Note: Tactical rifles will compete with other Tactical rifles combined into a separate category.

Entry Fees: \$40.00

Challenges: \$2.00 per challenge LOST.

Course of Fire:

Match #1 600 yard slow fire. Unlimited sighting shots with 20 rounds for record. Time limit of 30 minutes

Match #2 600 yard slow fire. 2 sighting shots with 20 rounds for record. Time limit of 22 minutes

Match #3 600 yard slow fire. 2 sighting shots with 20 rounds for record. Time limit of 22 minutes

Match #4 Aggregate of Matches 1, 2, and 3.

The Match Director is authorized to reduce the match in shots fired or distance due to range conditions. Refunds will not be provided once the match has commenced.

Empty chamber indicators are required – Rule 3.21

Bolt closing – All competitors shall close the bolt only when the rifle is parallel to the ground and pointed at the targets or the berm

Competitors are required to use ear protection and are encouraged to wear eye protection.

Every competitor is expected to have every shot somewhere in the target frame. Equipment capable of 15moa elevation above a 200 yard zero is required. Come with a 100, 200, 300 or 600 yard zero

Scorers need to ensure the shooter is on target. If a non-visible miss off the target cannot be attributed to a cross fire the scorer must inform the line officer.

The Chief Range Officer will have discretion to disqualify the competitor for the rest of the match

The Shot Marker will be used (NRA rule 10.17) competitors should bring an electronic device with sufficient power for a full day of operation and a browser capable of accessing an internal webpage over the range WiFi. Competitors are still required to score
