## **2016 Civilian Marksmanship Program (CMP) Matches Rimfire Sporter**

**June 18, October 15**

**These matches are fired outdoors, on concrete.**

**Match Officials:** Match Director: Paul L. Adamowski

**Match Conditions:** These matches are open to any and all US Citizens Shooters use shooter provided .22 Caliber Rimfire Rifles and appropriate ammunition. The Rimfire Sporter Match is for smallbore rifles that weigh 7 ½ pounds or less with sights. For these matches, rifles will be classed as O Class, or T Class. O class rifles have open sights. T class rifles have telescopic sights (with a maximum of 6 power) or receiver sights. Firing is done at 50 and 25 yards in prone, sitting/kneeling, and standing positions in both slow and rapid fire modes. Empty Chamber Indicators (ECI) and use of ear and eye protection is mandatory for Match events.

**Ammunition:** Caliber .22 ammunition only.

**Match Schedule:** Relays as required, starting precisely at 9:00 a.m.. Competitors should report to the range sixty minutes early with firearms and ammunition.

**Classifications:** There are no classifications.

**Challenges:** A challenge fee of \$2.00 will be charged for each challenge.

**Entries:** Entries close one half hour before the scheduled start time.

Preregistration for match events is **required** and can be made telephonically or via email. Contact information is included below. Participants will be required to sign a notarized Eligibility Affidavit and Liability Agreement if one is not currently on file at the range.

**Entries Limited:** Forty for each match.

**Squadding:** Pre-registrants will be squadded. If required, additional relays will be squadded in two hour intervals. Shooters should report at least one hour prior to scheduled shooting time for processing. Processing will cease one half hour before scheduled relay. Safety brief will commence fifteen minutes before scheduled relay. Non-registered shooters will be accommodated when space on line occurs.

**Fees:** Match - \$15.00

**Equipment:** All firearms and equipment must be in accordance with that described in CMP publication titled: Guide to CMP Rimfire Shooting and located on: <http://www.odcmp.com/NM/Rimfire.htm>

**Awards:** Awards will be based upon comparison of fired scores to “cut” scores furnished by the CMP based upon previous years match results. Shooters are effectively shooting against themselves for awards. Appropriate award to Match Winner and to high Junior.

### **Directions to Range:**

Traveling on Rt. 55, exit #24-Rt. 49 E. to Tuckahoe, continue 2.6 miles. Range entrance will be on left.

Traveling north or south on Rt. 50, turn west on Rt. 49, continue approx. 13.8 miles. Range entrance will be on right.

Traveling south on Rt. 54 to junction of Rt. 40, turn left go to far right lane, turn right on to Tuckahoe Rd. Continue to right fork-Union Road—continue to dead end on Rt. 49. Turn right 4/10 mile, range entrance will be on right.

Traveling on Garden State Parkway exit 38A Atlantic City Expressway to Camden/Philadelphia. Continue on Expressway exit at Hamilton Mall/Rt. 40 W. Continue on Rt. 40 W through Mays Landing. You will pass a diner and a WaWa on the right (traffic light at WaWa). Continue to next traffic light turn left and then right onto Bear's Head Rd., Mays Landing Rd., Millville Rd. Continue several miles, crossing railroad tracks continue again several miles to Union Rd. Turn left to dead end at Rt. 49. Turn right 4/10 mile, range entrance will be on right
