## **CMP CHAMPIONSHIP WEEKEND**

### **2015 Civilian Marksmanship Program (CMP) Championship Match, Governor's Ten and EIC Matches: September 19 & 20**

**Match Conditions:** Both day's matches will commence at 8 a.m.. The purpose of the **CMP Championship Match** fired on September 19 is to determine a State of New Jersey Champion in each of the Garand, Springfield and Vintage Rifle (GSV) categories as well as to determine an overall New Jersey State CMP Champion. To qualify as New Jersey State Champion a shooter must be a resident and fire a different rifle in each of the GSV categories. Purpose of the **Governor's Match** fired on September 20 will be to determine the top ten New Jersey Service Rifle Shooters. All matches are open to shooters who are citizens of the United States. For these CMP Matches, all rifles should qualify under and be in accordance with appropriate CMP rules governing specific rifles found at the CMP Website (<http://odcmp.com/Competitions>). GSV rifles are to be only "as issued". Only rifles classified as "Service Rifle" and listed under CMP rule 6.2 will be used in the Governor's Match. New Jersey has an assault gun ban. Guns falling under this ban will not be allowed on the range. This Ban does not affect Military Shooters, on orders, firing government issued guns (Gov 10). Match competitors will be required to furnish their own guns and ammunition. Empty Chamber Indicators (ECI) and use of ear and eye protection is mandatory for all match events. Participants will be required to sign a notarized Eligibility Affidavit and Liability Agreement if not currently on file at the range.

**Match Schedule:** Relays will be squadded. Competitors should report to the range a minimum of one hour prior to start time with firearms and ammunition. Triggers may be weighed and guns inspected to insure compliance with the appropriate CMP Rule. Shooters will be required to pull pit duty and score targets.

**Classifications:** There are no classifications.

**Challenges:** A challenge fee of \$2.00 will be charged.

**Entries:** Entries close one half hour before the published start time.

**Preregistration** for the match events **is strongly recommended** and can be made telephonically or via email. Contact information is included below.

**Entries Limited:** CMP Championship-30 per gun. Governor's Ten – 48 shooters.

**Fees:** Each GSV category- \$10 per match or \$25 for all three GSV Matches. Governor's Match -\$20. Entry fee for all four matches: \$40. (two days). EIC Match stands alone and fees for that match are \$20.

**Awards:** CMP Championships: CMP Pin Awards will be based upon comparison of fired scores to “cut” scores furnished by the CMP. Trophies will be awarded to the first place NJ resident competitor in each of the GSV classes. A New Jersey State Championship Trophy for the overall first place New Jersey resident competitor will be awarded. Champion will be determined by aggregate GSV score and must include a score with each gun (GSV). In those cases where the winner of the GSV category or championship matches is not a NJ resident, an appropriate trophy award will be presented.

**Governor's Match:** Trophy to High New Jersey Resident. Trophy to Match Winner if not NJ State resident. Recognition Brassards will be awarded to each of the top ten New Jersey resident participants.

**Courses of Fire:** New Jersey State Championship (GSV) will use the *AS Issued Military Rifle Course A* as listed in CMP rule 9.2.1.

New Jersey Governor's Match will be fired using the *President's Rifle Match Course of Fire* (Table 4) as listed in CMP Rule 8.2.1. The “X” Count will be the first determination in breaking ties. Further unresolved ties will be broken using high score in the Standing, then Slow Fire phases. Ties not resolved through listed methodology will require a shoot-off of ten rounds slow fire following completion of the match.

**Leg Match:** An Excellence in Competition (EIC) Match will follow the Governor's Ten Match on September 20. The EIC Match will commence following a break of about thirty minutes. All pertinent rules listed in CMP Rule Book, under rule 8.0 will pertain.

***Use of alcohol on club property is forbidden and will result in offenders' expulsion and forfeiture of all fees.***
