Firearms: Service Rifle with sights as defined in the Current Edition of the CMP Rule Book. Triggers will be weighed. See CMP website for current rule book.

Entries: Entry Fee: \$30.00 Adult \$15 Junior
Preregistration is encouraged.

Affidavit: A notarized "Eligibility Affidavit and Liability Agreement" as required by the CMP must be on file at this range prior to firing this match. If you require one, you can download it from www.odcmp.com

Squadding: Upon completion of GOV 10 Match, Approximately 1100 hours. It is strongly recommended that shooter preregister using entry information (below).

Firing starts: after completion of Governor's 10.

Course of Fire: NO Sighters!
200yds, SR target, 10 shots slow fire, standing Time Limit – 10 minutes
200yds, SR target, 10 shots rapid fire, from standing to sitting or kneeling.
Time Limit – 60 seconds
300yds, SR-3 target, 10 shots rapid fire, from standing to prone.
Time Limit – 70 seconds
600yds, MR-1 target, 20 shots slow fire, prone.
Time Limit – 20 minutes

Ammunition: Competitors supply their own ammunition.

Safety: Eye and ear protection are required.

NOTE: All NJ gun laws must be followed. 10 round magazine restriction is also in effect, all must comply.

Directions:

Traveling on Rt. 55, exit #24-Rt. 49 E. to Tuckahoe, continue 2.6 miles. Range entrance will be on left.

Traveling north or south on Rt. 50, turn west on Rt. 49, continue approx. 13.8 miles. Range entrance will be on right.

Traveling south on Rt. 54 to junction of Rt. 40, turn left go to far-right lane, turn right on to Tuckahoe Rd. Continue to right fork-Union Road—continue to dead end on Rt. 49. Turn right 4/10-mile, range entrance will be on right.

Traveling on Garden State Parkway exit 38A Atlantic City Expressway to Camden/Philadelphia. Continue Expressway exit at Hamilton Mall/Rt. 40 W. Continue Rt. 40 W through Mays Landing. You will pass a diner and a WaWa on the right (traffic light at WaWa). Continue to next traffic light turn left and then right onto Bear's Head Rd./Mays Landing Rd./Millville Rd. Continue several miles, crossing railroad tracks continue again several miles to Union Rd. Turn left to dead end at Rt. 49. Turn right 4/10-mile, range entrance will be on right

Traveling from the East – Route 49 east toward Millville. At Union Road, Ike's Famous Crab cakes is located (left side, western corner of intersection. Continue past Ike's for approximately four tenths of a mile. Range entrance is on the right side and is offset with a chain link fence. If you reach the power transmission lines, you have gone too far.
